Artists selected for participation in LexiCon 2019 will have some of their artwork on display in the Lexington Park Library Art Gallery for the month of September. Artwork to be hung in the Art Gallery must be prepared with hanging wire and or/hardware appropriate for metal hooks to be displayed on the Art Gallery's hook and track system. A label stating Artist Name, Name of Piece, and Price (or "NFS") should be included for each piece. Artwork must be dropped off at the Lexington Park Library by August 26. Artists may pick up their work on October 1.

4. Table at LexiCon

Artists will be provided with an exhibit table in the Art Gallery to show and sell their work during LexiCon. The exhibit tables will be available beginning at 11 a.m. on the morning of LexiCon. The exhibit space must be cleaned up and vacated by 4:30 p.m. on the afternoon of LexiCon. Artists will not be permitted to store materials at the Library before or after the event (except art that is to be hung in the Art Gallery).
